Insurance Coverage and Bad Faith Law

Brandon concentrates his practice primarily in the areas of insurance coverage and bad faith litigation, and complex commercial and business litigation. He represents international and domestic insurance companies in a wide array of coverage disputes in trial courts and on appeal in both state and federal courts. He has litigated and counseled insurers on issues involving numerous types of commercial and personal lines insurance policies, including commercial general liability, excess and umbrella liability, first-party property, builders' risk, healthcare liability, directors and officers liability, environmental liability, auto liability, trucking liability, homeowners insurance, life insurance, and other specialty insurance products. Brandon's coverage matters have included disputes over coverage for construction defects, environmental contamination, fires, explosions, equipment failures, latent and progressive injuries, sexual abuse claims, trucking accidents, and natural disasters. He also regularly represents insurers in high-exposure bad faith claims and has litigated and handled appeals in several of the most significant bad faith cases in Pennsylvania history. Brandon's coverage practice also includes regularly providing insurance coverage opinions and advice to insurers throughout the claims handling process.

In addition to his coverage work, Brandon has represented businesses and individuals in a wide variety of complex litigation matters, including cases involving restrictive covenants and trade secrets, securities fraud, breach of commercial contracts, professional liability of accountants, engineers and insurance brokers/agents, products liability, estates and trusts, civil rights, property damage and personal injury.

Brandon is currently Vice Chair of the Insurance Law Committee of DRI – the largest bar association of civil defense attorneys and in-house counsel in North America. In that role, Brandon assists with leading the Insurance Law Committee, which consists of over 2,700 members and serves as a key resource for professionals in insurance coverage and claims throughout North America. Representative Cases

Insurance and Bad Faith Matters

- Representation of lawyer professional liability insurer in a coverage action involving an alleged fraudulent scheme to sell 10,000 Bitcoin for over \$5.6 million. Reported decisions: *Zaftr Inc. v. National Liability & Fire Insurance Company d/b/a Attorney Protective*, 760 F.Supp.3d 275 (E.D. Pa. 2024) (motion to dismiss granted in favor of insurer); *Zaftr Inc. v. National Liability & Fire Insurance Company d/b/a Attorney Protective*, 2025 WL 3025675 (E.D. Pa. Oct. 29, 2025) (motion for judgment on the pleadings granted in favor of insurer).
- Representation of first-party property insurer in coverage and bad faith action involving multi-million dollar claim for property damage and business income loss arising out of vandalism and weather-related damage to a hotel.

Reported decisions: *Hydrojet Services, Inc. v. Sentry Insurance Company*, 2022 WL 2168655 (E.D. Pa. June 16, 2022) & 2022 WL 2168438 (E.D. Pa. June 16, 2022).
- Representation of insurer in suit seeking coverage for claims arising from alleged exposure to welding fumes containing hexavalent chromium. Summary judgment granted to insurer; affirmed on appeal. *Allegheny Ludlum, LLC v. Liberty Mutual Ins. Co. et al.*, 487 F. Supp.3d 350 (W.D. Pa. 2020), *aff'd*, 858 Fed. Appx. 49 (3d Cir. 2021).
- Representation of insurer in suit involving dispute over coverage for a product manufacturer for death claims arising from an airplane crash. Motion for judgment on the pleadings granted to insurer. *The Charter Oak Fire Ins. Co. v. Interface Performance Materials, Inc.*, 340 F.Supp.3d 437 (E.D. Pa. 2018).
- Representation of insurer in suit seeking coverage for claims involving construct defects in planned residential development. Summary judgment granted to insurer. *Northridge Village, L.P. v. The Travelers Indemnity Co.*, 2017 WL 3776621 (E.D. Pa. Aug. 31, 2017).
- Representation of insurer in coverage and bad faith action involving claims for coverage under a specified disease cancer insurance. Reported decision: *Rancosky v. Washington National Insurance Company*, 170 A.3d 364 (Pa. 2017).

- Representation of insurer in bad faith action arising out of dispute for underinsured motorist coverage. Reported decision: Grossi v. Travelers Personal Ins. Co., 79 A.3d 1141 (Pa. Super. 2013).
